Data Controller and Data Processors

The data controller processes the personal data of users by adopting the appropriate security measures to prevent unauthorized access, unauthorized disclosure, modification or destruction of personal data. Processing is carried out by means of computer and/or telematics instruments, with organisational methods and logics strictly related to the purposes indicated.
